

Dog Waiver

I hereby agree to the following regulations and conditions while staying at Hawk Valley Retreat and Cotttages ("HVR") with my dog:

- As a responsible pet owner, I agree to accept full responsibility for any and all damage and/or unusual degree of soiling caused by my pet during my stay.
- I agree to pay any additional cleaning bills or repairs should they be required and authorize HVR to charge my credit card for such charges, even if they are discovered following my departure from HVR.
- •I agree that HVR accepts no responsibility for a pet or pet owner who does not follow the items listed in this waiver
- •I agree to keep my dog on a leash or in a carrier while in public areas.
- I agree to keep my dog out of all buildings except the cottage I am renting.
- I agree to be present while any member of staff, such as housekeeping or engineering, is in the room.
- I agree that my dog, if left alone in the room, must be in its pet carrier/crate.
- I agree to prevent noise or any other disturbance by my dog, in the interest of other HVR guests.
- I agree that, should my dog create any disturbances, which cause complaints to be made to HVR by other occupants or personnel of HVR, at the request of the HVR manager, I shall immediately make arrangements to house my dog elsewhere outside HVR.
